

# TORRANCE AIRPORT NOISE MONITORING PROGRAM

Recently, the City of Lomita has received increased inquiries related to noise and air traffic at the Torrance Airport. In early 2021, the Torrance Airport Commission will be assessing the need to continue its noise abatement monitoring program and options for noise abatement at the Airport. The City of Torrance recently discontinued use of a noise monitoring system at the airport that allowed them to identify patterns and trends in helicopter operations and aid in future efforts to develop and implement noise abatement measures. City of Lomita Staff have continually worked with residents and with the City of Torrance and the Airport Commission to address this issue and minimize the airport-related impact on Lomita residential neighborhoods.

Currently, noise violations related to airport operations are being documented in preparation for a report that will be taken to the Commission and to make recommendations to the Torrance City Council. Lomita residents with concerns regarding noise at the airport, whether in response to specific operations or in general should continue to call or e-mail the Noise Abatement Center and report their concerns. Input received will be included in the forthcoming report to the Airport Commission. The ability to report the level of concern in the community regarding the Noise Abatement Program will be important in the assessment as to whether or how to continue such a program going forward.

#### NOVEMBER 2020 GENERAL ELECTION RESULTS

Measure L passed with over 60% support. The measures become operative on April 1, 2021, and the revenues received will be used to support local City programs and services in our community.

## LOCAL BUSINESS MAINTAINS COMMITMENT TO LOCAL VETERANS

23 years ago Battagliastile, a local Lomita small business - located at 2040 Lomita Blvd in Lomita - helped the City install a POW and Veterans Memorial at the Lomita Post Office to honor those who have served and given their lives for our Country. Recently, the memorial needed some repairs and modifications to keep it in pristine condition and ensure it will last for years to come. Once again, Battagliastile was happy to step up to the plate, and offered to complete the repairs free of charge.

Structural movement, trapped air, direct sunlight or moisture can sometimes cause tiles to pop out over time. Fortunately, the tiles on the Veterans Memorial were undamaged and Battagliastile was able to make the necessary repairs, and keep the memorial looking great! The repair work involved removing excess grout and applying new cement, glue and calk to reinforce the tiles.

The Lomita Veterans Memorial, located next to the Post Office at 25131 Narbonne Avenue, pays tribute to people who have lived in Lomita and give their lives in service to our country while fighting in World War I, Word War II, Korean War, and the Vietnam War. The original memorial was dedicated in November 1997 and a second wall was added later to include those who lost their lives in the Global War on Terrorism.







### CELEBRATING LOCAL CENTENARIAN AT SCI FITNESS

A South Bay native who turned 100 years old on December 13 celebrated his milestone birthday with a drive-by celebration attended by friends, family and neighbors. Jim Welsh has lived through events that changed history and now like all of us, is living through the global COVID-19 pandemic and the life-altering restrictions it brings. # 2020 STATE OF THE CITY ADDRESS

The City of Lomita held its 5<sup>th</sup> annual State of the City Address during a video conference on November 19, 2020 presented by the Lomita Chamber of Commerce. Over 100 guests listened in as the Mayor took the opportunity to provide an overview of the City's efforts in the areas of public safety, streets and water infrastructure, and fiscal stability amid COVID-19 during the past year.

As the Mayor reflected on the challenges faced by our community and the world this year, he focused on our City's resilience, recent progress and the road ahead for Lomita. "See a need, meet a need! That's the Lomita Way"

has proudly been this community's slogan during the pandemic and the City's Lift Up Lomita campaign can attest to that team effort. We have received numerous stories of the great acts of neighborliness in our community, Lomita lifting Lomita! Neighbors have been checking-in on neighbors, offering to pick up groceries and other needed items for an elderly friend or relative. The campaign's efforts began with monetary donations from City staff to support our community and it quickly grew from there. We have distributed more than 500 care packages to seniors and others in need when they need it most, which contain paper goods, face masks, bottled water, lists of local resources and other essential items as they become available.

At the direction of the City Council, the City offered thousands of dollars in direct support to local small businesses to help them get through the toughest of times, provided temporary protections against evictions to residential and commercial tenants, and suspended parking enforcement of street sweeping to allow residents to be safer at home.


Despite the financial challenges, the City has been able to move forward on projects that benefit our community, prioritizing water system improvements, street work, and traffic safety arounds schools. The City Council approved the newest upgrades to our treatment facility to add a Granular Activated Carbon filtration system to the plant, adding to the City's greatest asset - our ability to provide safe, clean, and local drinking water. The Mayor highlighted the improved condition of our local streets with the slurry resurfacing project and the Walnut Street improvement project which replaced a water main, rehabilitated the street pavement, fix sidewalk ramps, added bike lanes and traffic control signage indicating a new school bus zone to improve student safety around Fleming Middle School.

Voters passed Measure L with over 60% support and the City is committed to continue using revenues for the things our residents prioritize most - improving our water system, repairing our streets, keeping our parks and public areas clean and safe, maintaining our public safety response, and helping to support and retain our local businesses.

Captain Powers from the Lomita Sheriff Station and Captain Vazquez from Lomita Fire Station 6 also took part in the event with messages on what we can all do to keep our community safe and our Mayor Pro Tem closed the presentation with an informative question and answer session with our business community.

The Chamber took the opportunity to thank the numerous sponsors and provide an update on their efforts, highlighting the success of the Farmers Market, which takes place every Sunday from 10am-2pm at the Lomita City Hall front lawn.

### City of Lomita Heeds Residents' Calls to Upgrade Lomita Water System-Selects RC Foster Corporation to Construct New Filtration System at Cypress Water Production Facility

After listening to residents' concerns regarding Lomita's drinking water, the City of Lomita approved a series of upgrades to its water system specifically designed to improve the taste and odor of water distributed throughout the City. Furthermore, after much consideration and discussion over the project, the City Council has unanimously selected RC Foster Corporation to construct a new Granular Activated Carbon (GAC) filtration system at the Cypress Water Production Facility, advancing efforts to remove benzene, allow the City to return to its normal operations and reduce costs to residents.

"This project is something that I know our community has been looking forward to for a long time. We've heard our residents loud and clear - they asked us to bring them solutions to improve their water system, and we're proud to do just that," said the Mayor. "These upgrades are a direct result of grassroots input from Lomita residents; that's how local government is supposed to work."

The project involves the addition of GAC filtration vessels at the Cypress Water Production Facility that will filter out certain natural organic materials that contribute to the earthy odor that some residents may have noticed in the past. The upgrades will improve the aesthetic qualities of groundwater produced at the facility and also remove benzene that was detected at the site in 2019.

"These upgrades bring solutions to the concerns our residents have raised for many years, and will allow us to move forward and provide our residents with the first-class water system they deserve" said Lomita City Manager Ryan Smoot. "That is good news for the City and good news for our residents since the Cypress Water Production Facility helps us keep rates low by ensuring independence from more costly imported water sources and helps ensure the long-term sustainability of our water supply."

The City has secured approval from the State Department of Drinking Water for the upgrades, and the Water Replenishment District (WRD) has authorized the use of up to \$2,000,000 in grant funds for the project from its Safe Drinking Water Program - a program to assist local agencies in increasing their ability to produce water locally and improve drought resilience.

Construction of the upgrades is set to begin in February 2021, and is expected to take about 12 months to complete. # **SAFETY ELEMENT**



## The City is updating the Safety Element to meet new State requirements.

The Safety Element establishes policies related to future development that will minimize the risk of personal injury, loss of life, property damage, and environmental damage associated with natural and human-caused hazards. The Safety Element addresses the following hazards, including:







Materials







#### **Regional Integration of Safety Element**

The City's Safety Element must be coordinated with regional hazard mitigation, disaster preparedness, and emergency response plans in order to support an effective regional response to disasters and emergency.

#### **State Requirements**

Due to recently adopted State law (Senate Bill 1035), cities and counties must update the Safety Element at the time of the Housing Element update. Other recently adopted California State laws require the following to be identified, performed, updated, and included in the Safety Element:

Seismic and geologic hazards

Evacuation routes

Military installations

Peak-load water supply requirements

Minimum road widths and clearances around structures

Flood hazards

Fire hazards

Prepare a climate change vulnerability assessment and develop climate adaptation and resilience strategies

Identify residential developments in any hazard area that does not have at least two evacuation routes

# The City of Lomita is updating the Housing Element for 2021-2029

The Housing Element is a State-required component of every city's General Plan and must be updated for State-approval every 8 years. The primary focus of the Housing Element is to ensure decent, safe, sanitary, and affordable housing for current and future residents of the City, including those with special needs.

To address the existing and projected future housing needs of the City of Lomita, the 2021-2029 Housing Element Update will:

- Analyze demographics, economics & housing supply
- · Analyze housing constraints and resources
- Evaluate sites appropriate for potential housing
- · Develop goals, objectives, policies, & programs

## Why update the Housing Element?

California State law requires that the City update the Housing Element every eight years, because housing is critical to ensure economic prosperity and quality of life in our region. State law requires the adoption of the updated Housing Element by October 2021 but provides a 120-day grace period to comply. Non-compliance with State Housing Element law could result in fines and loss of sources of funding provided by the State.

#### What is RHNA?

RHNA stands for "Regional Housing Needs Assessment"
The Southern California Association of Governments
(SCAG) projects the housing needs and assigns a number
of housing units that the City is required to plan for. That
number of units is called the RHNA, and it is broken
down by income category, ensuring that all economic
groups are accommodated. This year, the regional
allocation was significantly higher than it has been in
past years and will require the City of Lomita to identify
a rezoning program to create the required capacity.
For the 2021-2029 planning cycle, the City received the
allocation below:

Very-Low	238 units
Low	124 units
Moderate	127 units
Above-Moderate	338 units
Total	827 units

#### STREET IMPROVEMENT PROJECT

In early 2016, the City Council established a goal to slurry seal all streets in the City within the next several years. Slurry seal is an efficient method to improve the ride quality of City streets while prolonging their usable life, resulting both in a safer drive and long-term taxpayer savings. To implement the program, the City was subdivided into seven street improvement zones (A-G). Slurry seal in Zones B, D, and E was completed in the Fall of 2016 and followed by Zone A which was completed in the Summer of 2018.

To streamline work efforts and costs, the findings of the 2018 Pavement Improvement Program (PMP) were combined with the Slurry Seal Program. Recently, the City contracted with Pavement Coatings Co to provide the recommended maintenance and repair strategies on the remaining zones (C, F, and G) in the northern part of the City as detailed in the PMP. The work included asphalt crack filing, asphalt skin patching, and the placement of slurry seal and chip seal.

Streets in these zones not paved as part of this maintenance work will be part of the Street Reconstruction Zones C and F Project. This will involve significant repairs and resurfacing of streets where slurry seal would not be sufficient to extend the life of the street. In addition, certain curb ramps will be replaced. It is anticipated the construction of this project will begin in Spring 2021.

The remainder of Zone G will be completed at a later date as the City has a pending grant application with the State for water main replacement and street pavement rehabilitation funding which would cover a portion of the costs.

The street maintenance program envisions ongoing street improvements where every street in the City is addressed every seven years. Funding for the program comes, in part, from the City's Street Improvement Funda special fund created by the City Council dedicated to street maintenance. The remaining funding comes from Gas Taxes, three different Los Angeles County measures to fund transportation improvements, and State funding.







# NEW DEVELOPMENTS IN LOMITA

You may have noticed construction projects currently underway in Lomita bringing new housing and commercial opportunities to our community.



#### **BROWNSTONE AT NARBONNE**

A new mixed-use project consisting of 2,700 square feet of commercial space, four live-work apartment units with commercial space facing Narbonne Avenue, and 11 three-bedroom condominium units is under construction at 2200 248th Street. The developer, Art Ashai, anticipates completion in mid-year of 2021.

#### **PICERNE APARTMENTS**

The Picerne Group recently broke ground on a 220-unit, apartment community at Crenshaw Blvd. and Lomita Blvd. This project is expected to be complete by the fourth quarter of 2022. The community, which is being built on 2.7 acres formerly occupied by equipment rental and storage business, consist of 35 studios, 134 one-bedroom and 51 two-bedroom units. Amenities will include a resort-style pool and spa with barbecue and fire pit areas, a clubhouse with media and game components, state-of-the-art fitness center, a roof deck and Wi-Fi throughout common areas.

#### NARBONNE BREWERY AND MIXED USE

Sciappa Development will be breaking ground in early 2021 on a 16-unit condominium development at 245<sup>th</sup> Street and Woodward Avenue. The project is in Phase 2 and follows the success of Phase 1 completed in 2019, with 3,700 square feet of commercial space and 5 apartments. Burnin Daylight Brewing Company occupies most of the commercial area.


As part of the project, the developer will purchase a portion of the adjacent public alley to create a paseo connecting the commercial portion of the project fronting on Narbonne Avenue with the residential uses in the rear.












#### **WILLIAMS MANOR APARTMENTS**

A 10-unit detached apartment development at 25819 Eshelman Avenue is nearing completion. Each apartment will feature three bedrooms and a private studio.

#### 24329 NARBONNE AVENUE PUBLIC PLAZA

The City acquired a property located at 24329 Narbonne Avenue with plans to use as public space. The City contracted with Studio One-Eleven to design an approximate 25-foot plaza area located at the front setback which can accommodate food trucks, pop-up shops, and small-business kiosks.





Behind the public plaza will be nine parking spaces, landscaping, and a bio-swale to capture storm water run-off. Construction is anticipated to start in January 2021.

# RESERVED PARKING NOT PERMITTED ON PUBLIC STREETS



While we understand that for many residents parking is often at a premium, we would like to remind residents that orange cones or other items cannot be used to reserve parking on residential public streets.

In California, street parking in residential areas is considered public parking and cannot be reserved, even if it is in front of your own home. Any member of the public can park so long as they are complying with parking regulations. City staff may remove orange cones and other items illegally placed on the street as these are obstructions and create safety hazards for traffic and pedestrians alike and can cause conflicts between neighbors.

On the other hand, if you encounter a vehicle you don't recognize as belonging to your neighbors that is parked for excessive periods of time without moving, you may contact the Lomita Parking Enforcement at (310) 325-7110 or Lomita Sheriff Station at (310) 539-1661 for assistance.
