At the public hearing you may appear and be heard, or you may write to the City Council in support of or in opposition to this matter. If you challenge the decision of the City Council in court, you may be limited to raising only those issues that were raised at this public hearing or in written correspondence delivered to the City Council at or before the hearing. **You will be allowed five (5) minutes** to speak before the City Council.

A copy of the proposed fee schedule is available for public review in the Office of the City Clerk. Should the master fee schedule be approved after the public hearing January 18, 2022, the fees shall become effective on March 19, 2022.
