NOTICE IS HEREBY GIVEN that the Lomita City Council will hold a public hearing at 6:00 p.m. on Tuesday, January 17, 2023, at Lomita City Hall, 24300 Narbonne Avenue, and via Zoom Meeting to consider the following:

POSSIBLE ADOPTION OF AN UPDATED A CITY-WIDE MASTER FEE SCHEDULE

The master fee schedule is a proposed update to the City's user fees and charges. Minor amendments are proposed with this update including an annual CPI adjustment. The master fee schedule includes new and updated fees for City services and activities within the following departments/divisions:

- Administrative Services Department
 - Business License
- City Manager's Department
 - Animal Care and Control
 - City Clerk
- Community Development
 - Building and Safety
 - Code Enforcement
 - Planning
- Parks and Recreation
 - Adult Sports
 - Adult and Senior Programs
 - Facility Rentals
 - Youth Sports and Programs
- Public Works
 - Engineering/Plan Check
 - Water Utility
 - Miscellaneous permit and inspection

Pursuant to AB361, the meeting may be held via teleconference. The Zoom link will be provided on the posted agenda. A copy of the proposed fee schedule is available for public review at the Office of the City Clerk, 24300 Narbonne Avenue, Lomita. Should the master fee schedule be approved after the public hearing January 17, 2023, the fees shall be effective on March 19, 2023.

At the public hearing you may appear and be heard, or you may write to the City Council in support of or in opposition to this matter. If you challenge the decision of the City Council in court, you may be limited to raising only those issues that were raised at this public hearing or in written correspondence delivered to the City Council at or before the hearing. **You will be allowed three (3) minutes** to speak before the City Council.
