3. Teen Program staff will call the Lomita Sheriff's Station and start making arrangements to turn over custody of the child. Staff will provide Lomita Sheriff's with a copy of child's contact information.

City of Lomita Parks and Recreation Department: Lomita Teen Program-Parental Fact Sheet and Waiver



Mission:

The mission of the Lomita Park Teen Program is to provide the future leaders of our community with an opportunity to learn life long social recreation skills. We strive to accomplish this in a safe and wholesome environment that allows our youth to grow as individuals while interacting as a group. The Teen Program offers a balance of activities, programs, and learning experiences that are designed to enhance each participant's physical, mental, and social well being.

Fee and Registration:

To attend and participate in the Teen Program at Lomita Park, one must be 11 years old or entering the 6th grade and be no older than 14 years old. There will be a fee of \$30 due at the time of registration. The attached Registration and Waiver & Release form must also be signed and completed by a parent or legal guardian granting permission for your teen's participation in Teen Nights, local excursions, and other activities held at Lomita Park. For all excursions, it is recommended that teens bring extra spending money for snacks or souvenirs. Parents may drop off and pick up their teens at Lomita Park for local excursions as we will be walking to and from the location.

Other excursions such as The Angels vs. Dodgers Game, Knott's Soak City, and Dave n Busters will require a separate waiver form (located on the back page of the brochure) and an additional fee for attendance. Priority registration will be given to participants who have paid their entrance fee and are registered into the Lomita Teen Program. If space remains after all Lomita Teen Program participants have been given a chance to register, other youth who meet the age restrictions will be permitted to register. Completed waivers may be submitted to the Lomita Park Recreation Office.

More Trip Information:

Angels vs. Dodger Game- July 7th- Cost: \$40.00: The Teen Program is heading to Dodger Stadium! The game will begin at 7:00pm, so our bus will depart from Lomita Park at 4:30pm and be returning at 10:30pm. Please be at the park no later than 4:00pm for check-in. Teens will need money for dinner and souvenirs if they choose. Clear bags no larger than 12"x12"x6" and non-clear wristlets/clutches no larger than 5"x8"x2" are permitted. Unopened snacks and beverages not in glass bottles, cans, thermoses, or coolers are also permitted. A separate waiver form signed by a parent or legal guardian will be required for this trip.

Planet Escape Room- July 13th - Cost: Included with \$30 Teen Program fee: The Teen Program will put their minds to the ultimate test while searching for clues and solving puzzles to escape the room! Participants are to arrive at Lomita Park no later than 11 am for check-in and are to return at 4 pm. The Teen Program will depart from and return to Lomita Park. Lunch will be provided. This excursion is local, so a separate wavier form will not be required.

AMC Theatres- July 19th- Cost: Included with \$30 Teen Program fee: The Teen Program will enjoy a summer movie at our local AMC Theatre, Rolling Hills 20. The Teen Program will depart from and return to Lomita Park. Teens will need money for beverages and snacks at the movies if they choose. This year's summer movie will be determined closer to the event. This excursion is local, so a separate waiver form will not be required. The time listed online is an estimate for this event as showtimes are not yet available.

Dave n Busters- July 20th - Cost: \$20: We will be spending the afternoon at Dave n Busters. The bus will depart from Lomita Park at 12:30 pm and return to the park at 4:30 pm. Please be at Lomita Park by 12:00 pm for checkin. Lunch will be provided as well as a \$15 game card with unlimited video game play. A separate waiver form signed by a parent or guardian is required for this trip.

Knott's Soak City- July 27th- Cost: \$30.00: We will be spending the day at Knott's Soak City hoorah! The bus will depart Lomita Park at 9:30am and return to the park at 5:00pm. Please be at Lomita Park by 9:00am for check-in. Teens will need to bring a sack lunch or money to buy lunch at the park. Proper swimwear is required, and a towel and sunblock are recommended.
